Despite the risk involved in alpine activities and in consideration of the right to participate in the USSA South Series Event February 18 and 19th and use of any facilities at Mountain High, I on behalf of myself and/or as the parent or guardian of the minor child identified herein, **ACCEPT AND ASSUME ALL RISKS OF INJURY OR DEATH, OR PROPERTY DAMAGE** that might be associated with or result from these activities. Falls and injuries are common occurrence while participating in any competitive activity and you must keep deliberate and conscious control of your physical body while participating in the named event and while using any snow sliding equipment in variable weather and terrain conditions. I understand that my safety or the safety of the minor child identified herein is directly affected by judgment during all weather and other related conditions. Participating in special events or other activities not specifically named require at times and increased level of skill and judgment, all participants are allowed to preview any of the course and or area's that events will be held. I agree for myself and/or minor child named herein to ski, snowboard and participate in other activities only within my/their ability. I agree to be alert to all risks, hazards and dangers at Mountain High Resort, including but not limited to: variations in terrain (including steepness and other variations, whether natural or as a result of slope design), surface or subsurface snow or ice conditions (whether natural or machine-made); bare spots; rocks; trees; stumps and other forms of forest growth or debris; lift towers and other resort area components including: lights, fences, posts and signs or components thereof (all of the foregoing whether above or below snow surface); pole lines and plainly marked or visible snowmaking equipment and other equipment, vehicles and machines including snowmobiles and Snowcats, uneven or slippery conditions, which may be present on roads, parking lots, walkways, and any other areas exposed to the elements of nature and are subject to the deposit , melting and refreezing of snow, rain, sleet, ice, such that walking or other daily activities may become dangerous, collisions with other skiers or snowboarders (whether as a result of failure to ski or ride within their ability or otherwise) or collisions with any of the risks and hazards included in this paragraph (whether natural or man-made), and other risks not known or reasonably foreseeable at this time. . In recognition of the risks associated with participation in alpine activities and related competition, I, on behalf of myself and/or as the parent or legal guardian of the minor child identified herein, **ACCEPT AND ASSUME ALL RISKS OF INJURY OR DEATH, OR PROPERTY DAMAGE** that might be associated with or result from these activities.

In consideration of being permitted to use the Mountain High Resort facilities for the above named event or activities, I agree to **RELEASE, INDEMNIFY, DEFEND AND HOLD HARMLESS** Mountain High Resort Associates LLC., its parent, subsidiary and affiliated companies, their respective agents, officers, directors, owners, contractors, volunteers, employees and insurers (collectively, the "Released Parties") from any and all claims, lawsuits, attorneys' fees and costs I might bring as a result of physical injury, including death, or property damage sustained in connection with my use of the Mountain High Resort facilities **INCLUDING CLAIMS BASED ON NEGLIGENT ACTS OR OMISSIONS, OR BREACH OF WARRANTY**.
